



A year or so back I had a conversation with a fellow, I'll call him Dave, who was working in my home installing new cable service equipment. He seemed intelligent and quite capable and I was curious as to how and why he would choose this line of work. Dave gave me a sad tale of being seduced by the video gaming industry, attending college to earn a bachelor's degree majoring in video game design and running up a huge student debt in the process. As the loan balance climbed, his lenders and advisors kept telling him that, upon graduation, when he landed his dream job with a big gaming company he would have no trouble repaying the loans. When Dave did graduate, however, the industry for which he trained was just heading into a three-year retrenchment and by the time it was ready to start hiring again, his training was out of date and he wasn't suited to the job market. Dave was being crushed by his heavy debt load, could not afford to go back to school to get current with the workplace requirements and, therefore, took a job crawling around in peoples houses while entering a program that allows him to make a minimum payment, based on his income, that will in no way retire his debt but will, as long as he keeps up his payments, forgive the balance after 20 years.

It's facile to dismiss Dave's experience as just an unfortunate anomaly to the benefits of higher learning through the magic of government guaranteed loan programs. The issue of student debt has blossomed into a national issue of major proportions that is calling to be addressed.

A troika of major sectors of our economy composed of industry, academia and lenders, has created an incestuous system which benefits them mightily with the welfare of the student a mere afterthought. Industry sets up job skill parameters, universities set up programs to train for those skills and lenders encourage students to borrow the funds necessary to pay the universities for that training. Industry benefits by getting an educated work force from which to pick and choose but, additionally, it can use its requirements as a POST Positions..

lever to claim an insufficient worker pool and import foreign workers to lower their wage costs. Academia benefits because it is able to charge runaway tuition fees with its promise of preparing students to meet the educational demands of its industrial partners. Lenders benefit by being able to sell, sell, sell, their loans to a young, naïve segment of society with encouragement from a government that guarantees the loans and that changed bankuptcy laws to preclude the recipient from legally ending his obligation.

The poor student doesn't stand a chance. He is offered no alternative by a system that, from his first day in kindergarten, is steeping him in the dogma of a must-have college education and hang the expense. Year after year, a tidal wave of new graduates enters the workforce just hoping to be able to find a position that will allow them to repay what is the equivilant of a home mortgage as they try to build a life. Similar to 19th century immigrants who sold themselves into indentured service to finance their way to America and its seeming endless potential for betterment, today's young are following a similar path of mortgaging their future in their attempt to participate in the American dream. What this amounts to is a modern form of indentured servitude and the master is the nebulous troika.

A partial panacea would be to offer apprenticeship programs to earn while you learn. For example, while there are some jobs that require a more well-rounded education, you don't need four years of college (and debt) to learn how to write computer code. A simple aptitude test and in-house training program would suffice, would be a boon to many youths entering the work force and place more of the burden for industry's artificial requirements where it belongs. The fact that Dave's training was "out of date" after three years shows that these companies are capable of training their employees on the job; the execs are keeping their current staff trained.

The only people who seem to be going to bat for these financially stressed students and graduates are progressives who are touting free college for all, which works out to be just another transfer of taxpayer dollars into the pockets of corporate America. Clearly industry wants to place the burden of a broad college education on their work force. I suspect that their education requirements would become much leaner if they were forced to finance it themselves.


